Because elected officials have such a significant influence on our workplace, the Camden Council #10 Political Action Committee (PAC) was formed in 1990. The Council #10 PAC is non-partisan, supporting both Democrat and Republican candidates based on their views on issues of importance to Council #10 and its members. Contributions to the PAC are used to educate the public and our members as well as to lobby officials on your behalf. ***Funding for this activity does not come from your dues.*** Instead it is provided through a separate payroll contribution available to all Council #10 members.

The Council #10 PAC has allowed us to have an impact on who gets elected and how elected officials view our members. In order to continue its work, the Council #10 PAC needs your financial support. ***Your contribution can be as little as \$1 from each paycheck.*** For that small amount, you can help make sure Council #10 members get a fair shake.

To join, fill out the payroll deduction authorization form and return it to your union representative or the Council #10 office. When considering whether you should join, remember that none of the money that P.A.C. receives goes to salaries or administrative costs. All money goes directly for making your views known and valued. And consider that the contribution is an investment that pays you back with a better workplace, higher wages and better benefits.
